Minutes of the Parish Council meeting held at 7pm on Monday 18th July 2022 in the village hall.

- 2. Minutes of the meeting held on 16th May 2022** - approved and signed
- 3. To consider matters arising from the above minutes:**
 - Potholes - the Clerk confirmed the potholes on Low Street and Long Lane have been marked for repair.
 - Zurich Insurance documents received as well as ICO certificate.
 - Jubilee BBQ - great success despite the weather, 100 residents attended. VH committee thanked for their input and Mrs Every responded on behalf of the VH.

- 7. Urgent Business** -
 - Speeding - The Clerk explained that it would not be possible to install "5 bar gate" type gateways opposite the current village gateways as there was insufficient space. Mrs Every repeated concerns of danger to life by vehicles being parked too near junctions, especially at the crossroads and near the church. She reminded the meeting that the highway code states no vehicle should be parked within 32 feet of a junction. It was suggested that a reminder go in the next newsletter.
 - The Clerk reported that requests for repainting of white lines at the crossroads have been made but will be repeated. ACTION - Clerk

- Cllr Stanley voiced concern over the collapsed state of Darlton Road near to the A57 junction. The Clerk will notify NCC Highways. ACTION - Clerk
- The Clerk to contact the drainage officer regarding the damaged pipework at Church Lane farm as a result of the jetting process carried out earlier in the year. ACTION - Clerk
