

# East Drayton Parish Council

Minutes of a Meeting of the Parish Council held  
at 7.30pm on Tuesday, 19<sup>th</sup> July 2011 in the Village Hall

## Present:

Cllrs N Stanley, A Stanley, H Mackintosh, P Ogle, M Goddard and I Stephens. In attendance: Clerk, S Pickard. Members of the public: 0.

1 **Apologies for Absence** – were received from Cllr R Small and CCllr J Hemsall.

2 **Minutes of meeting held on 21<sup>st</sup> June 2011** - were approved and signed.

## 3 Matters Arising

a) Village Signs - The Clerk read out an email received from Ian Fielding at Malcolm Lane & Son Ltd, inviting Councillors to the premises to see the new signs being produced. Councillors agreed to visit and suggested perhaps Mr Ellis may like to join them to take photographs for the website.

b) Best Kept Village Competition – The Clerk read out the Judges' comments and various points were made: *Most of the gardens were pretty good. Church grounds were neat and quite tidy. Litter bins OK and very little litter around the village. Grassed triangle at centre of village had scraps of litter where this had been cut by the mower. Some unkempt verges. Bus stops and shelters OK. No effort to outside of Village Hall. Notice board OK. No evidence of community activity. Not apparent telephone kiosk had become PC property (no effort made to make some use of this street furniture). Benches OK. All farms seen were neat and tidy. Leisure facility and associated area was very neat. The Blue Bell Inn had a lovely colourful display. No map supplied for judges.*

c) Queen's Diamond Jubilee – Cllr Ogle, Chairman of the Village Hall/Parish Council sub-committee, reported that Cllr Small had kindly agreed to offer a barn for a ceilidh (Pinch O' Snuff booked at £400; they will require a deposit). There will be sufficient lavatories as Cllr Small has some and the mess room facilities will be available by then. A cold buffet - ticket price £8/10 to cover costs only, for 100 people+. The Blue Bell Inn will provide the bar. To be advertised in the village newsletter and everyone was asked to 'spread the word'. On Bank Holiday Monday there will be a children's event on the sports field with a BBQ. The Landlord of The Blue Bell is aware of all the proposed events. There will be a village scarecrow competition. Arrangements to be stepped up Jan/Feb, but the venue/band/bar needed to be booked in good time. Concerning financial outlay, the Chairman proposed that Parish Council funds be used to enable organisation of the event and these be recouped from ticket sales. ALL AGREED.

d) Grass cutting – The Chairman had contacted Jeanne Wallace who advised the village will receive one cut, which was carried out the day after. The state of the gutters was also raised and although there were no plans to spray these at present because of cutbacks, if the situation changes East Drayton will be top of the list.
